CONTRIBUTORS

Helmut Anheier is Professor of Public Policy and Social Welfare at the University of California, Los Angeles (UCLA), and Director of the Center for Civil Society, and the Center for Globalization and Policy Research at UCLA. He is also a Centennial Professor at the Centre for the Study of Global Governance, London School of Economics and Political Science (LSE). His work has focused on civil society, the non-profit sector, organisational studies and policy analysis, and comparative methodology. He is a founding editor of *The Journal of Civil Society* and author of over 250 publications in several languages. His present research examines the emergence of new organisational forms in global civil society, the role of foundations, and methodological aspects of social science research on globalisation.

Patrick Bond is Research Professor at the University of KwaZulu-Natal School of Development Studies in Durban, where he directs the Centre for Civil Society. He has also taught at York University, Toronto, the University of the Witwatersrand, Johannesburg, and Johns Hopkins School of Public Health, Baltimore. His recent books include *Looting Africa: The Economics of Exploitation* (Zed Books and UKZN Press 2006); *Talk Left, Walk Right: South Africa's Frustrated Global Reforms* (UKZN Press 2006); *Trouble in the Air: Global Warming and the Privatised Atmosphere*, co-edited with Rehana Dada (CCS and the Transnational Institute 2005); *Elite Transition: From Apartheid to Neoliberalism in South Africa* (UKZN Press 2005); and *Fanon's Warning: A Civil Society Reader on the New Partnership for Africa's Development* (Africa World Press and CCS 2005).

Fadia Daibes-Murad specialises in water law and policy with specific emphasis on international water conflicts and resolutions. She is a Research Associate with the UNESCO Centre for Water Law, Policy and Science, Dundee, Scotland, and a Lecturer and Trainer of water law and policy at Birzeit University in the Occupied Palestinian Territory. She is a policy and strategic consultant for many international organisations. Her book, *A New Legal Framework for Managing the World's Shared Groundwaters - A Case-study from the Middle East* (International Water Association 2005), won the 2005 Edberg Prize for Environment in Sweden. She also edited *Water in Palestine: Problems, Politics Prospects* (PASSIA 2003).

Willemijn Dicke is Assistant Professor at the Faculty of Technology Policy and Management of Delft University of Technology in the Netherlands, and head of the research program Public Values within the Next Generation Infrastructures Foundation. In 2001 she published *Bridges and Watersheds: a Narrative Analysis of Water Management in The Netherlands, England and Wales* (Aksant), in which she explored the relation between globalisation and the public-private divide in water management. Her present interests include global public goods and the safeguarding of public values in a privatised context.

Heba Raouf Ezzat teaches political theory at the Department of Political Science, Cairo University. She is coordinator of the Civil Society Program at the Center for Political Research and Studies (CPRS) at Cairo University; and editor of the 'Arabic Version' of the *Global Civil Society Yearbook*, which will be published by CPRS in conjunction with LSE's Centre for the Study of Global Governance. She has published two books in Arabic on women, politics and morality in Islam, and contributed chapters on women, secularism, democracy and human rights, from an Islamic perspective, to a wide variety of English language publications. She is a member of the C-100 initiative by the World Economic Forum for Islamic-Western understanding.

Marlies Glasius is Lecturer in Global Politics at the LSE. She is the author of *The International Criminal Court: A Global Civil Society Achievement* (Routledge 2005) and *Foreign Policy on Human Rights: Its Influence on Indonesia under Soeharto* (Intersentia 1999). She was managing editor of the *Global Civil Society Yearbook 2000-2003*. She co-edited *Exploring Civil Society: Political and Cultural Contexts*, with David Lewis and Hakan Seckinelgin (Routledge 2004), and *A Human Security Doctrine for Europe: Project, Principles, Practicalities*, with Mary Kaldor (Routledge 2005). Her present interests include global civil society, economic and social rights, and human security.

David Goldblatt is a writer. His most recent book is *The Ball is Round: A Global History of Football* (Penguin 2006).

Mark Juergensmeyer is Professor of Sociology and Global Studies and Affiliate Professor of Religious Studies at the University of California, Santa Barbara, where he also serves as Director of the Orfalea Center for Global and International Studies. He is author or editor of 20 books including *Religion in Global Civil Society* (Oxford 2005), *The Oxford Handbook of Global Religions* (Oxford 2006), and *Terror in the Mind of God: The Global Rise of Religious Violence* (California 2003), for which he received the Grawemeyer Award in Religion and the Silver Medal of Spain's Queen Sofia Center for the Study of Violence. He is currently revising his presentation of the Stafford Little Lectures at Princeton for a book on religion and war to be published by Princeton University Press.

Mary Kaldor is Professor of Global Governance at LSE and Co-Director of the Centre for the Study of Global Governance, LSE. She has written widely on security issues and on democracy and civil society. Her recent books include *Global Civil Society: An Answer to War* (Polity Press 2003) and *New and Old Wars: Organised Violence in a Global Era* (1999). Most recently she co-edited *A Human Security Doctrine for Europe: Project, Principles, Practicalities*, with Marlies Glasius, (Routledge 2005). Mary was a founder member of European Nuclear Disarmament (END), and founder and Co-Chair on the Helsinki Citizen's Assembly. She is Convenor of the Study Group on European Security Capabilities established at the request of Javier Solana.

Hagai Katz is Lecturer at the Department of Business Administration at the School of Management at Ben Gurion University of the Negev in Beersheba, Israel, a Senior Researcher at the Israeli Center for Third-sector Research, and a Research Associate at the UCLA Center for Civil Society. He has published extensively on the non-profit sector in Israel and on global civil society. Hagai is editor of the Yearbook's Data Programme.

Sanjeev Khagram is Associate Professor of Public Affairs and International Studies, and Faculty Director of the Marc Lindenberg Center for Humanitarian Action, International Development, and Global Citizenship at the University of Washington. Most recently he was Acting Dean of the Desmond Tutu Peace Centre, and between 1998-2000 Senior Policy Advisor at the World Commission on Dams. He also co-directs Global Action Networks-Net, the Transnational Studies Initiative, and the International Advocacy NGO Initiative. He has published widely including *Restructuring World Politics* (University of Minnesota Press 2002), and *Dams and Development* (Cornell University Press 2004). Khagram has worked extensively with multilateral agencies, governments, corporations, civil society organisations, professional associations and universities, all over the world.

Denisa Kostovicova is Lecturer in the Government Department/Development Studies Institute and a Research Associate at the Centre for the Study of Global Governance, LSE. Her present research interests include nationalism and democratisation in the global age, post-conflict reconstruction and security, and European integration of the Western Balkans. She has also studied the role of education in identity formation and ethnic reconciliation in Serbia and Kosovo. Her publications include *Kosovo: The Politics of Identity and Space* (Routledge 2006), and 'Old and new insecurity in the Balkans: Learning from the EU's involvement in Macedonia' in *A Human Security Doctrine for Europe: Principles, Precepts, Practicalities*, edited by Kaldor and Glasius, (Routledge 2005). She also co-edited a special issue of *Ethnopolitics*, 'Transnationalism in the Balkans', with Vesna Bojicic-Dzelilovic.

Marcus Lam is a PhD student in the Department of Social Welfare at the UCLA School of Public Affairs and a graduate research assistant at the UCLA Center for Civil Society.

Alessandro Palmieri has worked in over 35 countries on several multi-purpose projects involving dams, hydropower, rural and urban water supply, and natural hazard management. He joined the World Bank in January 1997 after 22 years in the consulting engineering industry and is currently Lead Dams Specialist. He is co-author of two books on dam safety and reservoir sustainability, as well as several publications on water resources development. Alessandro currently represents the World Bank in the Steering Committee of UNEP's Dams and Development Project.

Jenny Pearce is Professor of Latin American Politics and Director of the International Centre for Participation Studies in the Department of Peace Studies, University of Bradford. Her work has focused on social change and social activism in Latin America and more recently in Bradford, the north of England. She is interested theoretically and empirically in exploring the conditions for a society to live without violence.

Yahia Said is a Research Fellow at the Centre for the Study of Global Governance, LSE. Yahia specialises in issues of economic transition and security in post-authoritarian and post-conflict societies. His publications include 'The New Anti-Capitalist Movement: Money and Global Civil Society', co-authored with Meghnad Desai, in *Global Civil Society 2001* (Oxford University Press 2001), 'Oil and Activism' in *Global Civil Society 2004/5* (Sage 2005), Regime Change in Iraq, co-authored with Mary Kaldor (CSGG 2003), and *New and Old Oil Wars* (Pluto Press, forthcoming), co-edited with Mary Kaldor.

Jill Timms is a Research Assistant at the Centre for the Study of Global Governance, LSE. She coordinates the Chronology of the Global Civil Society Yearbook and is completing her doctorate research on corporate social responsibility at the Department of Sociology, LSE. Her research interests include corporate citizenship, anti-corporate groups, labour activism and social forums. Her publications include 'Trade Union Internationalism and a Global Civil Society in the Making', co-authored with Peter Waterman, in *Global Civil Society 2004/5* (Sage 2005) and 'The Role of Social Forums in Global Civil Society: Radical Beacon or Strategic Infrastructure', co-authored with Marlies Glasius, in *Global Civil Society 2005/6* (Sage 2006).

Carlos B Vainer is Senior Professor at the Institute of Urban and Regional Planning and Research of the Federal University of Rio de Janeiro (IPPUR/UFRJ) and coordinates research at the Laboratory State, Labour, Territory and Nature (Estado, Trabalho, Território e Natureza). He also coordinates the Program of Research and Cooperation on Social Movements in the South: Brazil, South Africa, India and Thailand, which engages researchers and activists in a South-South dialogue. For 19 years, he has advised the Brazilian Movement of People Affected by Dams, is a member of the International Committee on Dams, Rivers and People, and the Forum of UNEP's Dams and Development Project. He has published widely on urban and regional planning models and theory, local and regional development, internal and international migration, environmental policies and conflicts, multilateral agencies and international aid, the impacts and social conflicts of large hydroelectric plants, and social movements and globalisation.

Zoë Wilson is a post-doctoral scholar at the Centre for Civil Society at the University of KwaZulu-Natal, South Africa, and a member of the Pollution Research Group at the University. Current projects concern the politics of alternative, appropriate and sustainable water and sanitation options. In affiliation with Newcastle University, Zoë leads a team of student researchers in mapping 'second order water scarcity' in South Africa. Other projects include studies into the effects of water infrastructure collapse in weak states. Zoë's first book, *The United Nations and Democracy in Africa: labyrinths of legitimacy is forthcoming* (Routledge 2006).

Patricia Wouters is Director of the Dundee UNESCO Centre for Water Law, Policy and Science, an expert in international water law and former practising lawyer in Canada. She was recruited to Dundee in 1996 to establish the water law postgraduate programme - the first of its kind in the world. Patricia has published extensively and is editor of two book series on water law and policy. A founding member of the UNESCO HELP programme and the Universities Partnership for Transboundary Waters, she also serves on the Foresight Advisory Committee for SUEZ Lyonnaise des Eaux, and was recently named a Fellow of the International Water Resources Association. Currently, Patricia is completing two books on international water law and implementing the 'Water Law, Water Leaders' programme, which aims to develop a new generation of local water leaders around the world.
